The CMAA League is for students who are currently in 3rd through 6th grades, however 2nd graders may choose to play up. Our league is an instructional program for players to develop skills. As the divisions/age advances it becomes more semicompetitive. Games typically begin the first week of June and end around the middle of July but no later than August 1st. Games may be played in Ashland, Hartsburg, Mokane, New Bloomfield, Auxvasse, Hallsville, Harrisburg, Centralia, Mexico or Sturgeon. (The league provides some batting helmets, should you choose to provide your own batting helmet for softball player(s), it is required to have a face mask attached to the helmet). Parents are responsible for providing or arranging transportation to and from practices and games.
