Your registration of **\$40 for YMCA members** and **\$50 for non-members** will include an NFL jersey and flag belt. Your player is encouraged to wear t-shirts, shorts, and athletic shoes for games and practices. Football cleats are encouraged but not required. Practices: All practices will be held at the Ashland City Park. Practices will begin around September 16th, 2017. Practice days and times will be determined by individual coaches.

Game Schedules: All flag football games will be held on Sunday afternoons between 12 pm and 5 pm at the Ashland City Park September 24th – October 29th. Game schedules will be handed out shortly after teams are determined.

League Rules: All league rules will be followed as written by the Youth NFL Flag Football League Program. Some rules may be amended if agreed upon by league. Information packets will be given to all coaches.

Team Parents: Team parents can be used to help distribute information, organize team activities, and help coach when needed. If you are interested in helping, please indicate on the attached registration form.
